No.1/8/2013-FX: The Office Memorandum No.1/4/92-FD(Exp) dated 17.03.1992 issued by this Government stipulated that the recommendations of a Tender Committee will be valid only till the last day of the Financial Year in which the Tender Committee gave its recommendation. This would mean that the validity periods of the recommendations would differ depending on when the recommendations were made. This variance and the difficulties of calling tenders within a year including avoidable waste of time and effort expressed by the departments of the government have been under consideration for some time now.

- 2. In order to have a more uniform validity period of tender recommendations, to do away with the need to call tenders within a year and also to avoid undesirable extension of validity periods of recommendations made, Government has now decided that the recommendations of a duly constituted Tender Committee which had considered tenders floated by following prescribed procedure and rules shall be valid for a period of 1(one) year from the date of recommendation.
- 3. The above shall take immediate effect and until further orders
